

The Chief Executive takes the view that s36 exemption applies in that to release contact information of individual employees would be prejudicial to the conduct of public affairs by causing potential approaches to managers who have no authority in this respect. This is because the Trust adheres to both NHS tendering and public sector procurement guidelines and speculative email and telephone approaches to managers are unwelcome. The senior responsible manager is the Director for IMT, as indicated.

We are aware that the public interest test applies and have taken into account that disclosure may promote accountability and transparency for the decisions taken by the officers concerned; we conclude that this consideration is satisfied by publication of accounts and scrutiny by the regulatory authorities. The Trust has therefore concluded that the public interest in maintaining the exemption outweighs the public interest in disclosure

In closing, it remains for me to advise you that if you are dissatisfied with the Trust's response to your request you have a right to complain to the Trust and should set out your concerns to Mr Peter Suter, Director of Information Management & Technology, London Ambulance Service NHS Trust, 220 Waterloo Road, London SE1 8SD. If you then still remain dissatisfied, you have a right under Section 50 of the FOIA to seek a determination from the Information Commissioner on whether the Act has been properly applied by the Trust.
